Amendment

The following amendments are made in the bid for "Supply of 220/132/11 kV," 200 MVA, and 160MVA AutoTransformers and Related Services for Sarusajai & Salekathi Grid Substations in Assam " of AEGCL.

- The following clause is added in Item SI No 4 of clause 3.27 (List of Equipments) of employers requirement.
 - "The Make and model of Automatic Capacitance & Tan Delta measurement kit should be Megger 4110 or equivalent Omicron Make."
- 2. Clause **3.25.2**, **SI-15** may be read as

15	a) Percentage Impedance at 75°C for 200 MVA (HV-IV)	10.3% (Max. tap), 12.5% (Nor tap), & 15.4% (Min. tap)
:	b) Percentage Impedance at 75°C for 160 MVA (HV-IV)	9.68% (Max tap), 9.70% (Nor tap), 10.14% (Min tap)
	c) Percentage Impedance at 75°C for 200 MVA & 160MVA (HV-LV) & (IV-LV)	45% & 30%

- 3. The clause **3.11.1.5** should be read as
 - "The 200 MVA transformers shall be capable of being operated, without danger, on any tapping at the rated MVA with voltage variation of 132 kV from (-) 5% to (+) 15% in 16 equal steps corresponding to the voltage of the tapping. And the 160 MVA transformers shall be capable of being operated, without danger, on any tapping at the rated MVA with voltage variation of 220 kV from (-) 5% to (+) 15% in 16 equal steps corresponding to the voltage of the tapping."
- 4. Clause 3.14.2.3
 - "Coil clamping rings, if provided shall be of fibre glass or wood."
- 5. Clause **3.17.2.5**
 - "Five numbers of probes shall be provided in fibre optics channel."
