1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, (“the Employer”) invites online bids through e-tendering from eligible bidders for
Construction of Store building at 132 KV Kokrajhar (Adabari) GSS

- 1.1. Bidder must create user ID in the web portal <https://aegcl.etenders.in> in order to participate in the e-tender.
- 1.2. Bidders must submit the bid for the complete package.
- 2.0 Bidder must download the bidding documents from the above mentioned portal and both technical & Price bid must be submitted through **online mode only** along with all scanned supporting documents (Suggested scan at 150 dpi in .pdf format). Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last minute unforeseen hassle. Bidders may be asked to submit the hard copies of all the supporting documents as and when required
- 3.0 Bidder must upload scanned copy of Earnest Money (in terms of Call Deposit/Bank guarantee from any Nationalized Bank certified by RBI payable at Dhaligaon) in favour of the **DGM, Bongaigaon T&T Circle, AEGCL, Dhaligaon**. Original instrument copy of Earnest Money has to be submitted at the office prior to one hour on the final time and date of submission of bid.
- 4.0 Bidder has to pay Non-Refundable tender document cost **@Rs.1000.00 (One Thousand) only** online through DEBIT /CREDIT card & NET BANKING etc.
- 5.0 Bidder has to pay Non-Refundable service fee online through DEBIT /CREDIT card & NET BANKING etc. as applicable to the e-tendering service provider in order to participate in the tender.
- 6.0 **Original Registered Joint Venture Agreement (if any) must be submitted before opening of the technical bid.**
- 7.0 Bidders must obtain class II/class III (Both Signing & Encryption) from any registered certifying Authority OR sub-certifying authority authorized by the CCA OR may contact M/S Nextenders (India) Pvt. Ltd (E-mail: support.assam@nextenders.com)
- 8.0 A **‘Single Stage Two Envelope’** bidding procedure will be adopted. Bidders are to submit simultaneously two bid online, one containing the technical proposal and the other containing the price proposal. Initially only the technical proposals shall be opened. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of Bidding Document will be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document shall be opened on a date notified in due course of time.

10.0 Qualification of the Bidder

- 10.1. To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Bidding Document.
- 10.2. Before submitting of the Bidding Document, the interested Bidders may visit the office of the **Deputy General Manager , Bongaigaon T&T Circle, AEGCL, Dhaligaon** or the web site of Assam Electricity Grid Corporation Ltd. (www.aegcl.co.in).

11.0 All bids must be accompanied by a bid security amounting to **Rs. 43,100 (Forty Three Thousand One Hundred Only)** in the form of Call Deposit/ Bank Guarantee from any Nationalized Bank in favour of the **DGM, Bongaigaon T&T Circle, AEGCL, Dhaligaon** payable at Dhaligaon. Scanned copy of the bid security must be included with the Technical Proposal. Bid security shall have to be valid for 30 days beyond the validity of Bid.

12.0 Opening of Bids

- 12.1. All bids must be submitted on or before the end time mentioned in the portal against this particular tender and the technical proposals will be opened after one hour of closing time of tender.
- 12.2. AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 13.0 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal).

14.0 Time for Completion:

- 14.1. All the works covered in the bidding document shall be completed within 120 days from contract signing / handing over of site.
- 15.0 AEGCL will not be responsible for any costs or expenses incurred on the preparation and online submission of the Bids.
- 16.0 AEGCL also reserves the right to issue or not to issue the Bidding Document to intending Bidders whose performance in past contracts with AEGCL are not satisfactory.
- 17.0 AEGCL is not bound to accept the offer of lowest bidder. The undersigned reserves the right to accept or reject any or all the bids without assigning any reason thereof.
- 18.0 **All the corrigendum's/addendums will only be published on <https://aegcl.etenders.in> and www.aegcl.co.in . Bidders are advised to regularly visit the sites for any updates.**
- 19.0 **Service provider/AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.**
- 20.0 **All other previous offline/Manual tendering process will be substituted by e-tendering process.**
