A Pre-bid meeting is held on 26-02-2020 as per the provision of the Cl. No.(A) (10) (a) of the bidding document. The members representing AEGCL and the prospective bidders discussed on the various clarifications and clauses of the bid document and the minutes of the meeting are as follows:

1. VARIATION AND DEVIATION OF QUANTITY: -

The terms & conditions of Bid document clause no.(C) (6) (a) have been amended as below The Tendered rates shall hold good for any variations in the Tendered quantities for legitimate completion of works as per original design on account of any modification in the bill of quantities. If AEGCL desires to procure any additional VRF Outdoor Unit / Indoor cassette unit within one year from the date of issue of work order, the contractor shall have to supply, install, test & commission the same at the quoted rate as mentioned in the work order. Any additional items (i.e. copper pipe, refrigerant etc.) required for supply, install, test & commission above mentioned VRF Outdoor unit/ Indoor cassette unit, the contractor shall borne the expenditure at his own expense.

2. Payment terms:

The terms & conditions of Bid document clause no.(C) (16) (c) have been amended as below

- (i) Within 60 (sixty) days from the date of submission of the invoice against supply, not more than 60 % (sixty percent) payment of the total supply invoice value would be made, on receipt and acceptance of materials in full and good conditions However GST amount on invoice would be paid 100% or as per Govt. Rules.
- (ii) Remaining 40% (forty percent) retention amount would be released subject to fulfillment of the following conditions
 - ➤ 50% of the balance supply amount would be paid on completion of 50% of the total erection works of the project.
 - Remaining 50% of the supply amount would be paid on completion of 100% erection, testing and commissioning activity of the project and after taking over by AEGCL.

3. TERMS AND CONDITIONS FOR COMPREHENSIVE ANNUAL MAINTENANCE CONTRACT.

The terms & conditions of Bid document clause no.(G) have been amended as below Comprehensive Annual Maintenance contract agreement will be signed with Original Equipment Manufacturer (OEM) only. The bidder shall have to furnish a letter from OEM in their official letterhead expressing their willingness for entering into an agreement with AEGCL for the Comprehensive Annual Maintenance contract. The contract for Comprehensive annual maintenance will be awarded with full responsibility of carrying out maintenance, repair and supply of required original spare parts with all necessary materials to keep the Air conditioner in fully operational condition for a period of 5 years after expiry of warranty period of 18 months from the date of handing over the Air conditioner.

NOTE:- All the sub-clauses under section-G shall remain same and unaltered.

4. The contractors are required to submit detailed time schedule within 7 days of issue of work order which shall be approved by AEGCL. Since multiple contractors will be working at the same location, contractors shall have to follow strict timeline as AEGCL's approved schedule so as to carry out the works in a synchronized manner. No deviation from the timeline shall be acceptable.

All other terms and condition of the Bid Document shall remain same and unaltered.
