1. With regard to the tenders with above-mentioned tender ref nos., this is to clarify that since the BoQ has been re-uploaded, the Tender Fees has to be freshly submitted. As for those bidders, who had already submitted the tender fees, the same shall be refunded within a few days.
2. With regard to the "PAYMENT MODE" during tender submission, the following details may please be noted:
 - When the option for selection of payment mode comes up, the website may show both "ONLINE" and "OFFLINE". In that case, the bidders are requested to select "ONLINE".
 - Following this, the website shall enable them to pay the non-refundable tender fees online, which is mandatory.
 - As for the EMD, the bidders are requested to opt "Yes" for "EMD through BG/EMD Exemption" and mention the percentage as 100%. The website will then redirect them to upload the scanned copies of the Hardcopy EMD BG.

It may be reiterated here, in line with the bid document, that the above has to be followed as the Tender Fees is to be submitted online and the EMD is to be submitted in the form of hardcopy BG.
