Following amendments are made to the bidding document:

- **Clause No. 16 (f) has been deleted and the new clause shall be read as follows:**

- **Addition of points in Clause No. 15 (b): Maintenance of the system installed:** The Successful Bidder has to submit a letter of Acceptance agreeing the Service Support from the OEM (Original Equipment Manufacturer) of the equipment (supplied and installed) for AMC to be provided for another 5 years after expiration of previous comprehensive AMC of 5 years.
- **Addition of points in Clause No. 20 (b): Performance Security (Bank Guarantee):**
Clause 20.4: As per the Additional Clause No. 15 (b) regarding the extended Service support of another 5 years after expiration of previous 5 years comprehensive AMC, a Performance Security of the Annual Maintenance Contract Value for another 5 years of Service support in form of Bank Guarantee (BG) shall have to be submitted to AEGCL by the successful bidder.
