1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Employer") invites online bids through e-tendering system from eligible bidders for below mentioned work:

Bidder must create user ID in the web portal <https://aegcl.etenders.in> in order to participate in the e-tender.

- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2. **Bidder should quote the rate excluding GST. Applicable GST will be added during the time of evaluation & awarding contract.**
- 2.0 Bidder must download the bidding documents from the above mentioned portal and both technical & Price bid must be submitted through **online mode only** along with all scanned supporting documents (Suggested scan at 150 dpi in .pdf format). Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last minute unforeseen hassle. **However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.**
- 3.0 Bidder must upload scanned copy of Earnest Money (in terms of BG) in favour of the **Chief General Manager, AEGCL, Bijulee Bhawan, Paltan Bazar, Guwahati-1.** Original instrument copy of Earnest Money (BG) has to be submitted at the office prior to one hour on the final time and date of opening of bid.
- 4.0 Bidder has to pay Non-Refundable tender document cost **@Rs.2000.00 (Two Thousand) only** & e-service fee online through DEBIT /CREDIT card & NET BANKING etc for each Bid Reference No separately.

- 5.0 Original Registered Joint Venture Agreement (if any) must be submitted before opening of the technical bid.**
- 6.0** Bidders must obtain class II/class III(Both Signing & Encryption) from any registered certifying Authority OR sub-certifying authority authorized by the CCA OR may contact M/S Nextenders(India) Pvt. Ltd (E-mail: support.assam@nextenders.com)
- 7.0** A '**Single Stage Two Envelope**' bidding procedure will be adopted. Bidders are to submit simultaneously two bid online, one containing the technical proposal and the other containing the price proposal. Initially only the technical proposals shall be opened. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements Bidding Document will be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document shall be opened on a date notified in due course of time.
- 8.0** Bidders may obtain further information from and inspect the bidding document at the office of the **Managing Director, AEGCL, Bijulee Bhawan, Paltanbazar, Guwahati-781001, Assam**, [Fax: 361 2739513 and phone: 361 2739520], e-mail: managing.director@aegcl.co.in; Web site: www.aegcl.co.in.]
- 9.0 Qualification of the Bidder**
- 9.1. To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 9.2. Before submitting of the Bidding Document, the interested Bidders may visit the office of the Managing Director for any query.
- 10.0** All bids must be accompanied by a bid security as stated in clause no-1 in the form of Bank Guarantee. Scanned copy of the bid security must be included with the Technical Proposal. Bid security shall have to be valid for 30 days beyond the validity of Bid.
- 10.1. The successful bidder will be required to furnish a contract performance guarantee for 10% of the total contract price in the form of a Bank Guarantee on award of the contract.
- 11.0 Opening of Bids**
- 11.1. All bids must be submitted on or before the end time mentioned in the portal against this particular tender and the technical proposals will be opened after one hour of closing time of tender.
- 11.2. AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 12.0** Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal).
- 13.0** Bidders must note that the expansion of National Highway is an extremely important national project and top priority has been accorded by the GOI & the State Government to expedite the project. Under these circumstances for raising the height of conductor of transmission lines AEGCL will reserve the right to suitably divide the works among the eligible contractors so that a contractor is not overloaded with works and the projects may be completed as per the stipulated time.
- 14.0 Time for Completion:**
- 14.1. All the works covered in the bidding document shall be completed within **6 (Six)** months from contract signing.
