- 1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites online bids (Through E-tendering portal) from eligible bidders for "Supply of 220/132/11 kV, 200 MVA Auto Transformer and Related Services for Sarusajai Grid Substation in Assam".
- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:
 - 1.2.1. Design and manufacture of one (01) no. of 220/132/11 kV, 200 MVA Auto Transformer, testing at manufacturer's works, supply and delivery at substation site with all accessories, mandatory spares & special tools/ testing kits unloading at sites.
 - 1.2.2. Supervision of erection, testing at site and commissioning of transformers.

- 3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non refundable tender fee of **INR 10,000.00** only though e-tendering portal.
- 4.0 For E-tendering, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal https://aegcl.etenders.in. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements Bidding Document will be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document shall be opened on a date notified in due course of time.

5.0 Qualification of the Bidder

- 5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

6.0 Submission of Bids

6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 19.06.2017.**

- All bids must be accompanied by a bid security amounting to **Rs. 16,00,000.00(Sixteen Lakh)** in the form of Bank Guarantee. Bid security shall have to be valid for **30 days beyond the validity of Bid.**
- 6.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG in original shall have to be submitted to the office of the Managing Director, 1(one) hour prior to bid opening.
- 6.4 AEGCL will not be responsible for any costs or expenses incurred on the preparation and submission/delivery of the Bids.

7.0 Opening of Bids

- 7.1 Techno-commercial bids shall be opened on 19.06.2017 at 14:00 Hrs. through e-tendering portal. AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2 Only those bidders the Technical Bids of whom are found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

8.0 SPECIAL NOTE TO BIDDERS:

- 8.1 Bidder must create user ID in the web portal https://aegcl.etenders.in in order to participate in the etender.
- 8.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- 8.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through <u>online mode only</u> along with all scanned copy supporting documents (suggested scan at 150 dpi in PDF with a file size upto 10MB). The documents should be duly signed, scanned and uploaded with proper name. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.
- 8.4 A Bidder will be required to pay a **Non-Refundable Service Fee** (Online only) in order to participate in the bidding process.
- 8.5 Service provider/AEGCL will not be responsible for misplacement/delay in receipt of e-tender OR BG copy sent through post/courier.
