1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Employer") invites online bids through e-tendering system from eligible bidders for below mentioned work:

Bid Identification No: AEGCL/MD/ TL-82(Pt-III)/2017 (Supply-A)

Package-A: *Manufacture, testing at manufacture's works, supply and delivery of 132 Kv Lattice tower superstructure including hangers, gussets, strain plate. Quantity as per Annexure I & Manufacture, testing at manufacture's works, supply and delivery of G I Nuts & Bolts. Quantity as per Annexure II.*

Bid Identification No: AEGCL/MD/ TL-82(Pt-III)/2017 (Supply-B)

Package- B: *Manufacture, testing at manufacture's works, supply and delivery of 11 KV Disc Insulators B & S Type. Quantity as per Annexure III.*

Bid Identification No: AEGCL/MD/ TL-82(Pt-III)/2017 (Supply-C)

Package-C: *Manufacture, testing at manufacture's works, supply and delivery of Hardware materials suitable for AAAC Panther conductor with tower line accessories (viz- Phase Plate, Number Plate, Anti-Climbing Device etc etc). Quantity as per Annexure IV.*

Bidder must create user ID in the web portal <https://aegcl.etenders.in> in order to participate in the e-tender.

- 1.1. Bidders shall be required to bid for the each Package separately and no part offer shall be accepted.
- 2.0 Bidder must download the bidding documents from the above mentioned portal and both technical & Price bid must be submitted through **online mode only** along with all scanned supporting documents (Suggested scan at 150 dpi in .pdf format). Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last minute unforeseen hassle. **However, AEGCL may ask bidder to submit hard copies of GTP, Drawing and any other documents if deemed necessary.**
- 3.0 Bidder must upload scanned copy of Earnest Money (in terms of BG) in favour of the **Managing Director, AEGCL, Bijulee Bhawan, Paltan Bazar, Guwahati-1.** Original instrument copy of Earnest Money (BG) has to be submitted at the office prior to one hour on the final time and date of opening of bid.
- 4.0 Bidder has to pay Non-Refundable tender document cost **@Rs.2000.00 (Two Thousand) only** & e-service fee online through DEBIT /CREDIT card & NET BANKING etc.
- 5.0 **Original Bank Guarantee & Registered Joint Venture Agreement (if any) must be submitted before opening of the technical bid.**
- 6.0 Bidders must obtain class II/class III(Both Signing & Encryption) from any registered certifying Authority OR sub-certifying authority authorized by the CCA OR may contact M/S Nextenders(India) Pvt. Ltd (E-mail: support.assam@nextenders.com)
- 7.0 A **'Single Stage Two Envelope'** bidding procedure will be adopted. Bidders are to submit simultaneously two bid online, one containing the technical proposal and the other containing the

price proposal. Initially only the technical proposals shall be opened. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements Bidding Document will be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document shall be opened on a date notified in due course of time.

9.0 Qualification of the Bidder

9.1. To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

9.2. Before submitting of the Bidding Document, the interested Bidders may visit the office of the Managing Director for any query.

10.0 All bids must be accompanied by a bid security amounting to **Rs.4,00,000.00 (Four Lakhs fifteen thousand) for Package-A, Rs 75,000.00 (Seventy five thousand) for package-B & Rs 15,000.00 (Fifteen thousand) for package-C** in the form of Bank Guarantee. Scanned copy of the bid security must be included with the Technical Proposal. Bid security shall have to be valid for 30 days beyond the validity of Bid.

11.0 Opening of Bids

11.1. All bids must be submitted on or before the end time mentioned in the portal against this particular tender and the technical proposals will be opened after one hour of closing time of tender.

11.2. AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.

12.0 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal).

13.0 Time for Completion:

13.1. All the works covered in the bidding document shall be completed within **fifty (50) days** from contract signing.

14.0 AEGCL will not be responsible for any costs or expenses incurred on the preparation and online submission of the Bids.

15.0 AEGCL also reserves the right to accept or not to accept Bids of Bidders whose performance in past contracts with AEGCL are not satisfactory.

16.0 AEGCL is not bound to accept the offer of lowest bidder. The undersigned reserves the right to accept or reject any or all the bids without assigning any reason thereof.

17.0 All the corrigendums/addendums will only be published on <https://aegcl.etenders.in> and www.aegcl.co.in . Bidders are advised to regularly visit the sites for any updates.

18.0 Service provider/AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.

19.0 All other previous offline/Manual tendering process will be substituted by e-tendering process.
