### **“ Turnkey Construction of 132 kV single circuit transmission link from Kamakhya Grid sub-station to Kamakhya Railway Traction sub-station”**

Following amendments are made to the bidding document:

- 1) Complete lattice tower structure type shall be 72% MS and 28% HT except stub setting template and nuts & bolts.
- 2) Item mentioned in BOQ 1 and BOQ 2 under SI No. 9.1 shall be read as -  
“132kV, 90 kN Long Rod Insulator, along with tension hardware fittings, nuts bolts etc complete with all accessories”. Rate of Tension clamp should be quoted only against item under SI No.10.6.
- 3) Unit of items mentioned in BOQ 4 & BOQ 5 under SI No. 5, 6, 9 & 10 shall be read as “Nos” in place of “m”.
- 4) Unit of items mentioned in BOQ 4 & BOQ 5 under SI No. 11 shall be read as “LS” in place of “m”. LS or Lump Sum indicates that the quantity of materials mentioned should be sufficient for completion of the entire scope of work.

All other terms and conditions shall remain same.
