The Government of India has applied for financing from the **Asian Infrastructure Investment Bank (AIIB)** towards the cost of the **Assam Intra-state Transmission System Enhancement Project**, and intends to apply part of the proceeds toward payments under the contract ¹for **Augmentation of the Communication Backbone-Replacement of the Existing Ground Wire by OPGW (636 km) (Package-M)**.
2. The Assam Electricity Grid Corporation Limited (AEGCL) now invites online Tenders from eligible Tenderers for ***“Design, Engineering, Manufacture, Assembly, Inspection, Testing at Manufacturer’s Works before Dispatch, Packing, Supply, Delivery at Site, Including Insurance During Transit, Subsequent Storage, Erection, Testing and Commissioning of OPGW by replacing the ground wire of existing 220KV and 132KV transmission lines and Terminal Communication Equipments in the existing Terminating 220KV and 132KV Grid Substations of AEGCL”*** on ***“Turnkey Contract Basis”*** as detailed in the Table below. The Tenderers may submit tenders for all of the Works indicated therein. Tenderers are advised to note the clauses on eligibility (Section 1 Clause 4), minimum qualification criteria (Section 3 – Evaluation and Qualification Criteria) to qualify for the award of the contract. In addition, please refer to paragraphs 4.4.1 and 4.4.2 of the “INTERIM OPERATIONAL DIRECTIVES ON Procurement Instructions for Recipient” setting forth the AIIB’s policy on conflict of interest.
3. Procurement will be conducted through National Competitive Tendering (NCT) method as specified in the AIIB’s “Procurement Instructions for Recipient, June 2016, and is open to all eligible Tenderers. Tenderers from India should, however, be registered with the Government of India or other State Governments/ Government of India, or State/ Central Government Undertakings. Tenderers, who are not registered as above, on the date of tendering, can also participate provided they get themselves registered by the time of contract signing, if they become successful tenderers².

required to register in the website. The tenderers would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.

6. For submission of the tenders, the tenderer is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link (www.cca.gov.in). Aspiring Tenderers who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://assamtenders.gov.in>. A non-refundable fee of **Rs. 30,000/-(inclusive of tax) or equivalent amount in a freely convertible currency**, is required to be paid. The method of payment will be online in the e-procurement portal. Payment documents are to be submitted as per the procedure described in paragraph 9 below.
7. Tender comprise two Parts, namely the Technical Part and the Financial (Price) Part, and both parts must be simultaneously submitted online on <https://assamtenders.gov.in> on or before **01st January, 2021, 14:00 Hrs**. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic tendering system would not allow any late submission of tenders. The "TECHNICAL PART" of the Tenders will be publicly opened online on **02nd January, 2021, 15:00 Hrs** in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below at 15:00 hours, and this could also be viewed by the tenderers online. The "FINANCIAL PART" shall remain unopened in the e-procurement system until the second public Tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.
8. All Tenders must be accompanied by a Tender Security of the amount specified for the Work in the table below, drawn in favour of Assam Electricity Grid Corporation Limited payable at Guwahati. Tender security will have to be in any one of the forms as specified in the tender document and shall have to be valid for 30 days beyond the validity of the tender.
