 - (b) Tests are conducted in manufacturer's own laboratory. In this case (i) the laboratory must have ISO 9000 (or its equivalent) series certification; and (ii) tests have been witnessed by technically gualified representatives of earlier clients or purchaser.
 - **3.1.3.** Test reports to be acceptable must be related directly to the materials offered.
 - 3.1.4. Test Reports older than five (5) years on the date of Technical bid opening shall not be accepted.
 - **3.1.5.** This clause has reference to bid document Clause 2.3.3, Appedix-2 of ITB, Section-1, 'Evaluation and Qualification Criteria'.
- 2) Clause 1.3.3.2(g) 'type test report' is replaced by 'test report'.
- 3) Form Exp-2 'type test report' is replaced by 'test report'.
- 4) Clause 1.6.1.1 award criteria amended as -
