2nd AMENDMENT & BID SUBMISSION DUE DATE EXTENSION

With reference to above, tender for "Supply, installation, testing & commissioning of Nitrogen Injection Type Fire Prevention & Extinguishing System at various substations under UAZ of AEGCL under PSDF (Package B)" the following amendment/clarifications are given to the bidding document:

1) The clause 2.3 and its sub-clauses are amended as below-

2.3.1 General Experience:

The Manufacturer(s) of the offered equipment(s) must have at least 5 (Five) years' experience of designing, manufacturing, testing and supplying similar rated equipment as on the date of bid opening. Using Forms EXP – 1 of Section 2 (Bidding Forms) the Bidder must furnish necessary information along with supporting documents (e.g., copy of contracts, performance & completion certificate, etc.) in support of this clause.

In case the bidder/ manufacturer does not have five years of manufacturing experience, AEGCL shall accept bid offered with manufacturing experience for at least three years provided that for such an exemption in experience the bidder shall have to submit additional guarantee/ warrantee and extended performance bank guarantee for a period which may fall short of stipulated period of five years.

2.3.2 Specific Experience

The Manufacturer(s) of the offered equipment(s) must have designed, manufactured and supplied the offered equipment to PGCIL/NTPC and other Indian Central and State sector Generation/Transmission Utilities and these should be in satisfactory operation for at least 3 (Three) year as on the date of bid opening. Using Forms EXP – 2 of Section 2 (Bidding Forms) the Bidder must furnish necessary information along with supporting documents (performance certificate) in support of this clause.

In case the bidder/ manufacturer does not have three years of specific experience (performance certificate for three years), AEGCL shall accept bid offered with performance certificate for at least two years provided the bidder shall have to submit additional guarantee/ warrantee and extended performance bank guarantee for a period which may fall short of stipulated period of three years".

In case, the bidder offer falls short in both the cases of the stipulated period as per clause 2.3.1 & 2.3.2, the bidder shall have to offer additional guarantee/warrantee and extended performance bank guarantee for the shortfall period whichever is higher".

Clarification regarding exemptions/purchase preference towards MSME

AEGCL shall follow the "Procurement Preference policy, Assam 2015" read with amendments if any.

All other terms and conditions of the bid read with earlier amendments remain same.

Extension of bid submission deadline:

Bid submission deadline is hereby extended upto 12:00 Hrs. of 06.07.2019. Technical bids shall be opened at 16:00 Hrs on 06.07.2019.
