## OFFICE ORDER

Whereas, two Nos. of bids were floated from the O/o the CGM, UAR at e-Tendering portal one for (i) Construction of 33kV Bay for APDCL at 220kV GSS Namrup on 21.07.2022 and the other for (ii) Construction of 33kV bay for BVFCL at 220kV GSS Namrup on 06.08.2022.

And whereas, on receipt of bids for Construction of 33kV Bay for APDCL at 220kV GSS Namrup, technical evaluation was conducted. Upon which, it was found that the some of the documents received from the bidders viz. Manufacturer's Authorization for 33kV SF6 breakers inter alia other equipment did not conform to the requirement dictated by the relevant clauses of the bid. Shortfall documents were sought accordingly and consequently the bidders submitted the called for shortfall documents.

And whereas, during scrutiny of the shortfall documents, it was observed that the Manufacturer Authorization of 33kV SF6 breakers for the 33kV bay for APDCL, submitted by one of the bidders viz. M/S Shiv Construction, Azara, Guwahati apparently issued from CGL appeared to be tempered. To defuse doubts regarding the authenticity of the document, on 09.11.22, CGL was e-mailed the documents and requested to confirm the authenticity. In response, authorized personnel of CG Power and Industrial Solutions Limited clarified that the Manufacturer Authorization in question was not issued from their end and declared the same to be false.

And whereas, it has thus been established that a doctored document in the form of Manufacturer's Authorization of 33kV SF6 Circuit Breaker was submitted by M/S Shiv Construction, Azara, Guwahati against the bid for "Construction of 33kV bay for APDCL at 220kV GSS, AEGCL, Namrup."

And whereas, upon unanimous view of the tender evaluation committee, an explanation was sought from M/S Shiv Construction, Azara, Guwahati to justify for such misdoing.

And whereas, the concerned firm in their reply placed the onus of the misdeed on M/S CGL and intimated AEGCL that they had reprimanded M/S CGL for the same. Although, any such documentary evidence to establish that M/S CGL was to blame and so absolving M/S Shiv Construction, Azara, Guwahati of the proven fault was not produced. That being the case, the explanation notice was found unsatisfactory by the tender evaluation committee.

And whereas, the firm was rejected from the bid "Construction of 33kV Bay for APDCL at 220kV GSS Namrup" by the concerned tender evaluation committee.

And whereas, although no such issue was detected in the documents of the concerned firm submitted against the bid "Construction of 33kV bay for BVFCL at 220kV GSS Namrup" the tender evaluation committee viewed that a proven misdeed of such severity as deliverance of doctored documents should be brought to books. On 28.12.2022 the tender evaluation committee decided to debar the concerned firm from participating in the bids of AEGCL for a period of one year

And whereas, the Hon'ble MD, AEGCL too accorded approval towards debarment of the firm

And whereas, on 05.01.2023 2<sup>nd</sup> explanation notice was issued to M/S Shiv Construction, Azara, Guwahati by which the firm was required to provide a valid cause to AEGCL by 09.01.2023 on the basis of which AEGCL refrains from taking such contemplated punitive measures as debarment.
