Tenderers from India should, however, be registered with the Government of India or other State Governments/ Government of India, or State/ Central Government Undertakings. Tenderers who are not registered as above, on the date of tendering, can also participate provided they get themselves registered by the time of contract signing, if they become successful tenderers.

Tender comprise two Parts, namely the Technical Part and the Financial (Price) Part, and both parts must be simultaneously submitted online on https://assamtenders.gov.in on or before 02nd February 2024, 13:00 Hrs. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic tendering system would not allow any late submission of tenders. The "TECHNICAL PART" of the tenders will be publicly opened online on 03rd February 2024, 15:00 Hrs in the presence of the tenderers' designated representatives. The "FINANCIAL PART" shall remain unopened in the e-procurement system until the second public tender opening for the financial part. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 8. All tenders must be accompanied by a Tender Security of the amount specified for the Work in the table below, drawn in favour of Assam Electricity Grid Corporation Limited payable at Guwahati.
