The Government of India has applied for financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the **ASSAM INTRA STATE TRANSMISSION SYSTEM ENHANCEMENT PROJECT** (PHASE-II), and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include project implementation support to the Implementing Agency (IA), project supervision, implementation of Environment & Social safeguard framework, review of electrical and civil drawings, supervising contractor(s) works, co-ordination with other government agencies, assist in procurement, quality monitoring, advice in financial matters, capacity building to the AEGCL officers including customized software for project management and monitoring, implement a comprehensive project management plan to ensure the most efficient, timely and economical implementation of each project components. The duration of this assignment is estimated for a period of 60 months.

The Assam Electricity Grid Corporation Ltd (AEGCL) now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are:

- A. The General Experience of the firm.
- B. Experience in Project Management and Supervision work in Extra High Voltage transmission engineering including survey, design and supervision of new installations (transmission line systems and AIS & GIS substations from voltage level 132kV 220KV)
- C. Audited financial turnover in the last three financial years.
- D. The firm should demonstrate that they have the experience to handle similar assignments in Power sector funded by **International Financial Institutions**.

- E. Experience in supervising of similar project(s) with conditions like hilly terrain, river crossing, waterlogged and forest areas etc. will be preferred.
- F. PMC should have well expertise in preparation of design/drawing of Electrical/Civil layout plan of substations using modern software. They should be well conversant of the IS guidelines and preparation and review of tower structure design of 220KV or above voltage level using modern software.

Expression of Interest (EoI) must include the following:

- Introductory letter on letter head (with complete contact details name of contact person, mailing address, telephone, fax, e-mail etc.) explaining how the firms is best to deliver the task;
- Organization profile;
- Annual reports for the last 3 years;
- Short note on the similar projects implemented by the Consultant Firm pertaining to the shortlisting criteria; and
- Details of relevant similar projects undertaken in the past 10 years.

Experts and other staffs will not be evaluated at the shortlisting stage.

The EoI should contain sufficient supporting documents to substantiate the claim of the Consultant towards their qualification as per the short-listing criteria.

The attention of interested Consultants is drawn to Section II, paragraph 4.4, and paragraph 4.9 of the AIIB's "Procurement Instructions for Recipients" June 2, 2016, setting forth the AIIB's policy on conflict of interest and eligibility.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost Based Selection Method set out in the Procurement Instructions for Recipients.
