- III. The Earnest Money Deposit will be 2% of tendered value and bid paper cost will be Rs. 100/- only for all tenders.
- IV. The rates for the various works will be taken from the **DSR 2021/2022** or **APWD SOR 2013-14** with 20% escalation or lowest quoted rate or as per available supporting/official documents.
- V. In case of any emergency work, quotations/ price bid will be collected from the empaneled contractor directly against short quotation notice.
- VI. Scope of work and other relevant information shall be as per the bid/tender document.
- VII. Empanelment of the firms/parties/Contractors will be termed valid only after signing of the Contract agreement on non-judicial stamp of Rs. 100.00 denomination with AEGCL by the Contractor within 10 (Ten) working days from the date of issue of this order.
- VIII. The contractors are requested to ensure revalidation of the registration fee of Rs. 2000.00 (Two Thousand) within 07 (Seven) working days from the date of issue of this order without fail.
- IX. Termination: If the performance of the contractor is not satisfactory and not corrected within 7 days of receiving notice, then **AEGCL shall be at liberty to terminate the contract** and get the work executed through other means at the risk and cost of the contractor.
- X. Terms of payment:
 - a) Payment will be subject to availability of specific fund.
 - b) The Security Deposit (SD) money of 10% will be deducted from the bill & will be released after the warranty period of 18 months.
